Harm Reduction After Hours.

Stand alone harm reduction services (2018).

- -Needle exchange program had limited hours from 08:30 am to 16:30 pm.
- -Operated Monday to Friday.
- -Fixed location.
- -The program was driven by health authority policy/work standards.
- -No Peer involvement.
- -Missing opportunity to provide Harm Reduction services to a group of people not accessing services for various reasons.



HRAH Initial Design

- -Develop an outreach program to help address the issues of sexually transmitted diseases such as HIV and Hepatitis C.
- -Provide harm reduction supplies and education to high risk populations
- -Program facilitated by Peers connected to the community and have personal experience with using injectable equipment/harm reduction supplies.



Birth of HRAH.

_

- -Formed a focus group of peers with lived experience. Meetings occurred through out the duration of the project.
- -Provide mobile secondary exchange.
- -Hire Peers who currently or have used injectable drugs and personally practicing harm reduction.
- -Provide an extra 36 hours of harm reduction services Monday through Sunday (weather permitting).
- -Peer focus group designed the program/rules of conduct etc.



HRAH Mission Statement

Bringing home wounded warriors thru empowerment and honour. The HRAH (Harm Reduction After Hours) team will do so through the promotions of safer drug use and invitations /healthy living programs for the urban people of Prince Albert and by doing so it will enrich lives and health through teamwork and continuous support.



HRAH Peers.

- -Recruitment: Posters in HR sites, word of mouth, focus group members.
- -Payed a wage.
- -Training on: services available at sexual clinic, HIV, Hepatitis C, Safe drug use (including cook your wash), Naloxone training, risk reduction strategies, current information on treatment, and community referrals.
- -Peers signed project and privacy agreements.
- -Peers provided input: hours of work, weekend/stat holidays, weather conditions (when they go out or not), needle packaging, routes (where and when).



HRAH Meat and potatoes.

- -5 peers hired/ 1 coordinator.
- -Schedules provided/developed with input from Peers.
- -HRAH photo ID badge.
- -Police informed of HRAH Peers/program. Also received copy of photo ID for each Peer.
- -Monthly bus pass or equivalent in gas if they drove.
- -Meal cards (\$20) for each shift worked.
- -Summer/winter clothing and footwear provided.
- -Worked in pairs of two for safety reasons.

HRAH Wins

- -284,281 needles distributed.
- -73,310 needles returned.
- -6,554 needles picked up in the city of Prince Albert.
- -12,422 inhalations pipes distributed.
- -735 referrals made.
- -15,498 client contacts.



HRAH Challenges

- -Finding/maintain Peers.
- -COVID- No HRAH services April May 2020 and 3 weeks in November, 2021.
- -Extreme cold/heat days.
- -Coordinator had to make up harm reduction supply kits.



Client survey August 3 to 19, 2022

- -96 surveys completed.
- -54.2% used HRAH services daily.
- -20.7% used HRAH services every second day.
- -86.9% clients stopped sharing needs/equipment due to HRAH services.
- -70.8% stopped sharing meth/crack pipes.
- -93.8% educated on how to use safely from HRAH Peers.
- -88.5% educated about cooking their wash.
- -94.8 % received information on Access Place (sexual health clinic in PA).
- -85.4% received information on HIV.
- -83.3% received information on Hepatitis C.
