MLTC was created by nine First Nations located in north-west Saskatchewan who have constitutionally recognized aboriginal rights and Treaty Rights under Treaties #6, #8 and #10. The primary purpose of MLTC is to serve those First Nations in their aspirations for cultural, economic and political autonomy. As a private sector employer engaged primarily in promoting and serving the interests of the member First Nations, MLTC asserts its right to provide preferential treatment to First Nations people, giving them priority in decisions on employment matters such as hiring, and this can extend to measures such as opening competitions only to First Nations people.

- Preference will be given to qualified First Nations applicants or other Indigenous applicants who self-declare as being a First Nations person or of other Indigenous ancestry;

The Meadow Lake Tribal Council is seeking a LLRC Numeracy Consultant to join the Office of Education. The LLRC Numeracy Consultant will support the implementation of the LLRC curriculum, best-practice instructional strategies, and assessment initiatives. This position will use an Indigenous lens to coordinate and support teachers in implementing LLRC Curriculum competencies, strength-based assessment for learning that align with School Success Plans and Land-Based Calendars. This position will develop meaningful and supportive relationships with MLFN schools, to ensure consistency between program supports and MLTC.

#### **Duties & Responsibilities:**

#### **Projects Collaboration:**

- Attend regular internal meetings with Coordinators/Consultants based on the involvement in regard to the specific initiatives
- Responsible for the implementation of school-based needs and providing long-range second-level service & delivery modeling, co-planning, co-teaching, co-assessment.
- Responsible for timely feedback/reporting of project outcomes and successes to the coordinator
- Monitoring and follow-up on project timelines
- Regular communication with designated school-based administrators and coordinators/consultants/coaches

#### PD Delivery

- Facilitation of PD presentation (provide rationale for contract requests/fee for service for PD, school-based needs and external consultants, content development, resource material preparation)
- Support for all event planning details and collaboration with team members

#### **Budgets & Reports**

- Collaborate as a team to provide estimates for ordering of resources and PD delivery
- Responsible for submission of monthly reports and data to Coordinators.
