ROLE: Under the direction of the WCHC Health Director & Nurse In Charge, the NP will join our growing team of medical professionals to provide services to the community of Montreal Lake Cree Nation; in conjunction with the MLCN Nursing Program objectives, guidelines procedures and policies, and the needs of the community; provides a Primary Care nursing treatment service to the community; advises the Nurse in Charge on matter relating to nursing and perform other duties as delegated by Health Director & Nurse in Charge.

RESPONSIBILITIES:

Primary Care Services:

Your duties will include recording patients' medical histories, performing physical exams, administering diagnostic tests, and creating patient care plans. You will also administer treatment and observe patients' functioning over time.

- Performing physical exams and patient observations.
- Recording patients' medical histories and symptoms.
- Creating patient care plans and contributing to existing ones.
- Ordering, administering, and analyzing diagnostic tests.
- Monitoring and operating medical equipment.
- Diagnosing health issues.
- Administering medicine and other treatments.
- Detecting changes in patients' health and modifying treatment plans, as needed.
- Consulting with healthcare professionals and families.
- Training patients and their families to manage and prevent illness and injury.
- Works collaboratively with other members of the health care team members.
- Co-ordinates services and care with the patient to ensure continuity and follow-up.
- Referring clients who require medical or dental care
- Completes a comprehensive documentation using SOAP charting on EMR.
